NOTIFICATION

In pursuance of Board of Management Resolution No 748 passed in the meeting held on 07.10.2016 read with the Sub- statute 29 (2) of Utkal University of Culture 1st Statute 2001 and subsequent orders passed by the Vice- Chancellor, temporary affiliation is granted in favour of DRIEMS School of Hotel Management, Kairapari, Tangi, Cuttack to conduct the following courses as per the student strength mentioned against each for the academic session 2016-17 with the following terms and conditions.

Conditions

- 1- The Institution should procure required teaching aid equipments for production lab, house keeping, food and beverage service, bar and front room.
- 2- They should have adequate classroom for accommodation of 30 students in BHM and 30 students in MHM course before beginning of the current academic session.
- 3- Infrastructure should be developed as per the needs of the students and as per the requirement of the courses.
- 4- They should purchase adequate numbers of text books and reference books for the library keeping in view the requirement of the students and the syllabus.
- 5- Governing Body is to be formed within a period of 2 months within the scope of Society Act 1860 as per the Sub- statute 36 of Utkal University of Culture 1st Statute 2001 taking the nominee of Vice- chancellor and Director of Culture, Odisha, Bhubaneswar.
- 6- The Institution should have adequate numbers of qualified teachers. During the appointment of teachers there should have an observer expert and a subject expert from Utkal University of Culture.
- 7- Fire fighting measures must be adopted on the institution.
- 8- Acquitance Roll should be maintained properly. Subsidiary cash book should be maintained for the institution.
- 9- Hostel to be constructed / or taken of rent for residential accommodation of students depending on requirement.

10 The institution should not admit the fresh batch of students without prior approval of the University.

- 11 If the institution is already affiliated to another University and comes under jurisdiction of the said University, the institution has to submit a "No Objection Certificate" from the concerned University and the concerned department that they have no objection if the institution is affiliated to Utkal University of Culture within a period of two months, failing which action as deemed proper shall be taken by the University.
- 12- The institution must have to complete its own infrastructure on the land owned by it within 10years of temporary affiliation on a progressive basis if it is running on a rented building and apply for grant permanent affiliation as no temporary affiliation can be renewed beyond 10 years as per the Statutory provision.
- 13- This University has reserved every right either to revoke or suspend the affiliation in the event of any anomaly/ litigation/ discrepancy/ fraud on the part of the institution.

The above points should be complied at the earliest.
