Sub: Renewal of temporary affiliation for the academic session 2017-18.


Sir / Madam,

In inviting a reference to the subject cited above I am to inform you that as per provision contained in Part- V, Chapter- I, substitute- 29 (II) of the Utkal University of Culture 1st Statute-2001, it is mandatory on the part of the affiliated colleges / institutions to make an application requesting for renewal of temporary affiliation on payment of prescribed fees before 30th April of the year preceding the academic year in which the next batch of student is to be admitted. In view of this the temporary affiliation in respect of your college / institution for the academic session 2017-18 is required to be renewed.

It is therefore, impressed upon the colleges / institutions to take appropriate steps to renew their temporary affiliation by depositing the required renewal fees for the courses as mentioned against each along with the status report of the college / institution within the stipulated time as envisaged in the statute, failing which action as deemed proper will be taken at this end. In this regard I am to inform you that while submitting the status report, special care should be taken to indicate regarding purchase of land of the college / institution of its own and development of infrastructure thereon.

Further it is to be noted that admission to MSW, MJMC and MWS courses have been banned w.e.f. the session 2014-15 by the Govt. in Tourism and Culture (Culture) Department which has been communicated to all affiliated colleges / institutions vide this office letter NO 239 / UUC dt 10.12.2014 which may please be referred to.
