## **NOTIFICATION**

In pursuance of Resolution of Board of Management of the University vide No.796 (C) passed in its meeting held on 24.07.2017 read with the Sub-statute 29 (2) of Utkal University of Culture 1<sup>st</sup> Statute 2001 and subsequent orders passed by the Vice- Chancellor, temporary affiliation is granted in favour of Trytoon Academy, Plot No.3574/5486, Palasuni Hat, Canal Road, Rasulgarh, Bhubaneswar to conduct the following course (as per the U.G.C. Regulation) and as per the student strength mentioned against the course for the academic session 2017-18 with the following terms and conditions.

### **Name of Course**

### **Student strength allowed**

**Bachelor of Fashion Design  
[B.Des. (Fashion)]**

**15 (Fifteen)**

### **Conditions**

1. The Institution should develop the Garment Lab and Pattern Cutting Lab.
2. They should have adequate classroom for accommodation of 15 students in course before beginning of the current academic session.
3. Infrastructure should be developed as per the needs of the students and as per the requirement of the courses.
4. The institution should purchase adequate numbers of text books and reference books for the library keeping in view the requirement of the students and the syllabus.
- 5.. Governing Body is to be formed within a period of 2 months within the scope of Society Act 1860 as per the Sub- statute 36 of Utkal University of Culture 1<sup>st</sup> Statutes, 2001 which should include the nominees of the Vice-Chancellor and the Director of Culture, Odisha, Bhubaneswar.
6. The Institution should have adequate numbers of qualified teachers. During the appointment of teachers there should be an observer expert and a subject expert from Utkal University of Culture.
7. Fire fighting measures must be adopted in the institution.
8. Acquittance Roll should be maintained properly. Subsidiary cash book should be maintained for the institution.
9. Hostel to be constructed/taken on rent for residential accommodation of students depending on requirement.

10. The institution should not admit the fresh batch of students nor should admit students beyond the sanctioned strength without prior approval of the University.

11. If the institution is already affiliated to another University and comes under jurisdiction of the said University, the institution has to submit a "No Objection Certificate" from the concerned University and the concerned department that they have no objection if the institution is affiliated to Utkal University of Culture within a period of two months, failing which action as deemed proper shall be taken by the University.

12. The institution must have to complete its own infrastructure on the land owned by it within 10 years of temporary affiliation on a progressive basis if it is running on a rented building and apply for grant permanent affiliation as no temporary affiliation can be renewed beyond 10 years as per the Statutory provision.

13. The University reserves the right either to revoke or suspend the affiliation in the event of any anomaly/litigation/ discrepancy/fraud committed on the part of the institution.

The above points should be strictly adhered by the institution.
