NOTIFICATION

In pursuance of Resolution No.796 (c) and No.849(iv) passed by the Board of Management of Utkal University of Culture in its meetings held on 24.07.2017 and 16.02,2018 respectively read with the Sub-Statute 29 (2) of Utkal University of Culture 1st Statute 2001 and subsequent orders passed by the Vice-Chancellor, temporary affiliation is granted in favour of **Regional College of Management, Plot No.GD 2/12 & 2/13, Chakadoladham, Chandrasekharpur, Bhubaneswar-751023** to conduct the following course (as per the U.G.C. Regulation) and as per the student strength mentioned against the course w.e.f. the academic session 2017-18 with the following terms and conditions.

Name of Courses

Bachelor in Hotel Management (BHM)

Student strength allowed

40 (Forty)

Conditions

1. The Institution should procure required teaching aid equipments for production lab, house keeping, food and beverage service, bar and front room.
2. The institution should have adequate classrooms for accommodation of 40 students in BHM course before the commencement of the programme.
3. Infrastructure should be developed as per the needs of the students and as per the requirement of the courses.
4. The institution should purchase adequate numbers of text books and reference books for the library keeping in view the requirement of the students and the syllabus.
5. Governing Body is to be formed within a period of 2 months within the scope of Society Act, 1860 ~~as~~ as per the Sub-Statute 36 of Utkal University of Culture 1st Statute 2001 which should include the nominee of the Vice-Chancellor and the Director, Culture, Odisha, Bhubaneswar.
6. The Institution should have adequate numbers of qualified teachers. During the appointment of teachers there should have an observer expert and a subject expert from Utkal University of Culture.
7. Fire fighting measures must be adopted on the institution.
8. Acquittance Roll should be maintained properly. Subsidiary cash book should be maintained for the institution.
9. Hostel to be constructed/taken of rent for residential accommodation of students depending on requirement.

10. The institution should not admit the fresh batch of students nor should admit students beyond the sanctioned strength without prior approval of the University.

11. If the institution is already affiliated to another University and comes under jurisdiction of the said University, the institution has to submit a "No Objection Certificate" from the concerned University and the concerned department that they have no objection if the institution is affiliated to Utkal University of Culture within a period of two months, failing which action as deemed proper shall be taken by the University.

12. The institution must have to complete its own infrastructure on the land owned by it within 10 years of temporary affiliation on a progressive basis if it is running on a rented building and apply for grant permanent affiliation as no temporary affiliation can be renewed beyond 10 years as per the Statutory provision.

13. The University reserves the right either to revoke or suspend the affiliation in the event of any anomaly/litigation/discrepancy/fraud committed on the part of the institution.

The above points should be strictly adhered by the institution.
