6. The Institution should maintain adequate numbers of qualified teachers. During the appointment of teachers, there should have an observer expert and a subject expert from Utkal University of Culture.
7. Fire fighting measures must be adopted in the institution.
8. Acquittance Roll should be maintained regularly. Subsidiary cash book should also be maintained regularly for the institution.
9. The institution should not admit the students beyond the sanctioned strength in any academic year.
10. The institution should provide adequate facilities for students with disabilities.
11. Hostel to be constructed/or taken on rent for residential accommodation of students depending on requirement.
12. The institution should also have proper grievance redressal and prevention of sexual harassment mechanism.
13. The institution should also install CCTV surveillance system on the campus.

If the institution is already affiliated to another University and comes under the jurisdiction of the said University, the institution has to submit a 'No Objection Certificate' from the concerned University and the concerned department that they have no objection if the institution is affiliated to Utkal University of Culture within a period of two months, failing which action as deemed proper shall be taken by the University.

15. The institution must have to complete its own infrastructure on the land owned by it within 10 years of temporary affiliation on a progressive basis if it is running on a rented building and apply for grant of permanent affiliation as no temporary affiliation can be renewed beyond 10 years as per the statutory provision.

16. The University reserves the right either to revoke or suspend the affiliation in the event of any anomaly/litigation/discrepancy/ fraud committed on the part of the institution.

In pursuance of Resolution of Board of Management of the University vide No.870 passed in its meeting held on 20.04.2018 read with Sub-Statute 29 (2) of Utkal University of Culture 1st Statutes, 2001 and subsequent orders passed by the Vice-Chancellor, Temporary Affiliation is granted for additional 30 number of seats to conduct **Bachelor in Hotel Management (B.H.M.) course** (as per UGC Regulation) in favour of **Shalom Institute of Management Studies, At-Khodasingi Main Road, Near LIC Building, Berhampur-10** with effect from the academic session 2018-19 with the following terms and conditions. The temporary affiliation now granted is in addition to the temporary affiliation granted previously vide Notification No.2513/UUC dated 10.11.2014 for 60 seats during the academic session 2014-15.

Conditions

1. The Institution should procure required teaching aid equipments for production lab, house keeping, food and beverage service, bar and front room.
2. The institution should maintain continuously adequate classrooms for accommodation of 30(additional) seats in B.H.M. course in addition to previously temporary affiliation granted for 60 seats during the year academic session 2014-15 vide Notification No.2513/UUC dated 10.11.2014 before beginning of the academic session 2018-19.
3. Infrastructure should be developed as per the needs of the students and as per the requirement of the course.
4. The institution should purchase adequate numbers of text books and reference books for the library keeping in view of the changing requirements of the students and the syllabus.
5. Governing Body is to be formed within a period of 2 months within the scope of Society Act 1860 as per the Sub-statute 36 of Utkla University of Culture 1st Statute 2001 taking the nominee of the Vice-Chancellor and Director of Culture, Odisha, Bhubaneswar.
