NOTIFICATION

In exercise of the powers conferred by the sub-section 34 of the Utkal University of Culture Act, 1999 (Odisha act of 1999), the Board of Management with the approval of Government, make the following amendments to the First Statutes of the Utkal University of Culture, 2001, namely:-

1.(1) These Statutes may be called the Utkal university of Culture (Amendment) Statutes, 2019.

(2) they shall come in to force on the date of their publication in the Odisha Gazette.

2. In the Utkal University of Culture, 2001 (hereinafter referred to as the said statutes) in statute-31, in clause (vi), for Sub- Clause- (1) a & b, (2) a & b, the following sub-clauses shall be substituted, namely:-

(1(a) MHM, BHM, MTTM, BTTM, BFD, BTD, BID, MRM and other professional courses Rs.4,00,000/-

(Four Lakh only) per course

(b) Courses on Performing Art and Visual Art and other

Art & Crafts related courses

Rs.1,00,000/- (One Lakh only)

Per course

(2) Renewal Course Fee-

(a) MHM, BHM, MTTM, BTTM, BFD, BTD, BID, MRM and other professional courses Rs.75,000/-

(Seventy five thousand only) per course

(b) Courses on Performing Art and Visual Art and other

Art & Crafts related courses

Rs.30,000/- (Thirty

(3) In clause (vi) after sub-Clause (6), the following Sub-Clause shall be inserted, namely:-

(7) Permanent affiliation fee,

(a) MHM,BHM,MTTM,BTTM,BFD,BTD,BID,MRM and other professional courses Rs.5,00,000/-

(Five Lakh only)per course

(b) Courses on Performing Art and Visual Art and

Rs.2, 00,000/-(Two Lakh only)
