NOTIFICATION

After making comprehensive assessment of the prevailing COVID-19 pandemic situation and following the principles of UGC guideline on Examinations and superseding this office notice No.161/UUC Dt. 05-06-2020 and No.166/UUC Dt. 08-06-2020, the following guidelines have been approved by Utkal University of Culture to be implemented in forth coming EVEN Semester Examinations, 2020.

GUIDELINE FOR EVEN SEMESTER EXAMINATION,2020

Under Graduate (UG) EVEN Semester Examinations under CBCS System.

1. The EVEN Semester Examinations i.e. 2nd, 4th, 6th and 8th Semester Examinations (Both Regular and Back, Theory and Practical) of all UG courses shall not be held for this academic session 2019-20. The students of 2nd, 4th and 6th Semester shall be automatically promoted to the next semester for 2020-21 academic session.
2. **The evaluation for 8th Semester Examinations shall be made at par with average of marks obtained in all the previous semesters.**
3. **The evaluation for 2nd, 4th and 6th Semester shall be made in proportionate with the percentage of marks secured in the previous semester. In this method evaluation shall be made on the performance of the student in the previous semester examination both for Mid-Sem and End-Sem (Theory and Practical) Examination i.e. for 2nd Semester, performance of 1st Semester shall be considered for evaluation and so on. In case, any student was absent in the previous semester of the current 2nd, 4th or 6th Sem, the marks of preceding semester of previous semester shall be considered for evaluation. Those students who have not appeared the 1st Semester Examination shall not be eligible for consideration of promotion.**
4. For Back paper examinations, if a student has maximum two back papers, University shall adopt PQ Method to evaluate for the said paper/s. The results of the Back Examination of such students shall be declared along with other students of 8th Semester Examination. However, if a student has more than 02 back papers, then s/he has to appear regular examination in all back papers as and when conducted in the next EVEN Semester Examination, 2021. Therefore, results of such students will not be declared along with other regular students of 8th Semester Examination.
5. The traditional back examinations of BVA and BPA as notified vide this University notification No.61/UUC Dt. 29-02-2020 shall not be held for this academic session 2019-20. The evaluation of performance of students shall be made at par with average of marks obtained in all the previous semesters (both for theory and practical) or PQ method as per applicability.
6. Those students of Final Semester i.e. 8th Semester Regular, who feel that s/he might have secured higher marks over the present evaluation method, University shall conduct 8th Semester Regular Examination in the month of November, 2020 and the revised result shall be published in the month of December, 2020.

Post Graduate (PG) EVEN Semester Examinations under CBCS System.

1. The EVEN Semester Examinations i.e. 2nd and 4th Semester Examination (Regular and Back, Theory and Practical) shall not be held for this academic session 2019-20. The students of the 2nd semester shall be automatically promoted to next semester for 2020-21 academic session.
2. **The evaluation for 4th Semester Examination shall be made at par with average of marks obtained in all the previous semesters.**
3. **The evaluation for 2nd Semester shall be made in proportionate with the percentage of marks secured in the previous semester. In this method evaluation shall be made on the performance of the student in the previous semester examination both for Mid-Sem and End-Sem (Theory and Practical) Examination i.e. for 2nd Semester, performance of 1st Semester shall be considered for evaluation. Those students who have not appeared the 1st Semester Examination shall not be eligible for consideration of promotion.**
4. For Back paper examinations, if a student has maximum two back papers, University shall adopt PQ Method to evaluate for the said paper/s. The results of the Back Examination of such students shall be declared along with other students of 4th Semester Examination. However, if a student has more than 02 back papers, then s/he has to appear regular examination in all back papers as and when conducted in the next EVEN Semester Examination, 2021. Therefore, results of such students will not be declared along with other regular students of 4th Semester Examination.
5. Those students of Final Semester i.e. 4th Semester Regular, who feel that s/he might have secured higher marks over the present evaluation method, University shall conduct 4th Semester Regular Examination in the month of November, 2020 and the revised result shall be published in the month of December, 2020.

M.Phil 2nd Semester Examination

1. The M.Phil 2nd Semester Examination (Regular and Back) shall be held for this academic session 2019-20. The detail examination programme shall be notified later.

Eligibility of Students for Consideration of Promotion to the next Semester


1. The student who are going to appear 8th Semester Examination of UG Courses, 4th Semester Examination of PG courses and 2nd Semester Examination of M.Phil Courses shall have to fill their examination registration forms on On-Line mode by paying usual examination fee as notified vide this University notification No.102/UUC Dt. 13-03-2020. However, students will not pay any Centre Charge to the concerned college/institution.
2. The students who are supposed to appear 2nd Semester Regular Examination of both UG and PG courses must have appeared their 1st Semester Examination (at least one theory end sem paper) to be considered for promotion to the next semester. Further the students who are supposed to appear 4th and 6th Semester Examination of all UG courses must have registered for 1st Semester Examination and must have appeared at least one previous semester examination in order to be eligible for promotion to the next semester.
3. The students who are supposed to appear their 2nd, 4th and 6th Semester (both Regular and Back) Examination in 2020 for all UG courses and 2nd Semester Regular Examination, 2020 of all PG courses are required to fill their forms on On-Line mode by paying revised examination fee as per details below. Only those students, who fill the examination forms, shall be considered for promotion to the next semester.

4. The students who have already filled-up their examination forms for 2nd, 4th and 6th Semester Examination, 2020 by paying usual fee as per the notification No.102/UUC Dt. 13-03-2020, the excess amount paid over the revised amount as mentioned above shall be adjusted in their next semester examination form fill-up. All institution heads are required to submit a statement of account showing student wise fee paid and amount to be adjusted after publication of results of all examinations in the prescribed format available in the University website. The said format is also enclosed herewith.

These decisions have been taken in the context of COVID-19 pandemic and shall not be made/cited/treated as precedence in future.


