

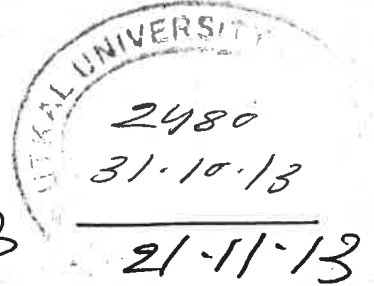

No. 2339-UUC.—In exercise of the powers conferred by sub-section (2) of Section 34 of the Utkal University of Culture Act, 1999 (Odisha Act 9 of 1999), the Board, with the approval of Government, hereby make the following amendment to the First Statutes of the Utkal University of Culture, 2001 namely :—
