Sub : Renewal of temporary affiliation for the academic session 2021-22.

Sir/Madam,

In inviting a reference to the subject cited above, I am directed to inform you that as per provision contained in Part-V, Chapter-I, sub statute-29(II) it is mandatory on the part of affiliated colleges/institutions to make an application requesting for renewal of temporary affiliation on payment of prescribed fees (as mentioned below) before 30th April of the preceding academic year in which the next batch of students is to be admitted. However, due to Covid-19, the month April, 2021 passed through a lock down period. In view of the lock down, the admission 2021-22 process has also been shifted by the Govt. As per decision of Board of Management vide resolution No.116 dated 23.6.2021 that you are required to deposit the renewal fee of the temporary affiliation by 31st August, 2021 in respect of your College/Institutions for the academic session 2021-22.

It is, therefore, impressed upon the Colleges/Institutions to take appropriate steps to renew their temporary affiliation by depositing the required renewal fees for the courses as mentioned against each along with the status report of the colleges/institutions within the stipulated time as envisaged in the statute, failing which action deemed proper will be taken at this end.

It is to be noted that admission to MSW, MJMC and MWS courses have been banned with effect from the session 2014-15 by the Govt. in erstwhile Tourism and Culture(Culture) Department which has been communicated to all affiliated college/institutions vide this University letter No.239/UUC dated 10.12.2014 may please be referred to.

Further, it is clarified that every college/institution shall have a Governing Body which shall be registered under the Societies Registration Act-1860 instead of any Trust Act, as per Statute 36(1) of First Statutes, 2001 of Utkal University of Culture.
