

**GUIDELINES FOR THE APPOINTMENT OF CHAIR PROFESSOR
UTKAL UNIVERSITY OF CULTURE, BHUBANESWAR**

Objectives of the Chair Professor.

1. The Chair Professor should carry out in-depth teaching and research in their relevant subjects.
2. All the four chairs shall focus on teaching & research and in turn, contribute to the advancement of knowledge in the broader area of study, the historical / social / cultural context and also in comparative perspective. Besides, efforts should be made to explore the contemporary relevance of the area of study specified for them. The academic timing of the Chair Professor will be 10.30 A.M. to 5.30 P.M. on all working days like other regular faculty members of the university. They need to participate in teaching & Ph.D. programme as per the UGC norms.
3. In an academic year, at least two research papers shall be published in Scopus-indexed / WoS-indexed / UGC Care journals under the auspices of the chairs. Besides, monographs / books / reports / articles may also be published under the auspices of the chairs.
4. The quarterly report regarding the activities of the chair to be submitted to the University which shall be reviewed by a duly constituted Committee.
5. The Chair Professors shall organize at least one national seminar / conference in an academic year; and at least one international conference or seminar in every two years. He / she may also participate in the academic and developmental activities of the university.
6. The chair shall be located in one of the Department / Schools of the university and shall be provided all the academic, administrative & logistic support extended to the Department / School.
7. Duration of the Chair - Maximum of 3 years or until the incumbent attains the age of 65 years, whichever is earlier.

Eligibility Criteria.

8. The tenure of assignment shall be initially for a period of one year, or up to maximum age limit of 65 years depending on the budget provision by Govt. of Odisha and satisfactory performance of the Chair Professors.
9. The Chair Professor shall be a person with outstanding academic achievements in the designated area of studies. Applicants for the said post should be atleast of the rank of Reader / Associate Professor or an 'A' grade National level Artist in the relevant field. The applicant should have expertise in the specific area of study which shall be assessed on the basis of their publications in reputed journals / books as well as academic record / expertise in the designated area of studies.
10. The monthly remuneration for Chair Professor shall be Rs. 50,000/- (Rupees fifty thousand only).

Period of Appointment.

12. The appointment will made for a period of 01(one) year which is likely to be extended yearly for 02 (two) more years subject to availability of funds and satisfactory performance. The tenure of the Chair Professor shall not exceed 03 (three) years.
