Sub: Renewal of Temporary Affiliation for the Academic Year **2025-26** Sir / Madam,

This has a reference to the subject mentioned above, I am directed to inform you that as per Part-V, Chapter-I, Sub Statute-29(11) of the Utkal University of Culture, 1<sup>st</sup> Statutes, 2001, it is mandatory on the part of affiliated colleges / institutions to make an application requesting for renewal of temporary affiliation on payment of prescribed fees before 30<sup>th</sup> April of the year preceding the academic year in which the next bench of student is to be admitted.

It is, therefore, impressed upon the colleges / institutions to take appropriate steps to renew their temporary affiliation by depositing the required renewal fees for the courses as mentioned against each within the stipulated time as envisaged in the Statute, failing which actions deem proper will be taken at this end.

Further, it is to be noted that admission to MSW, MJMC, MWS courses have been banned for the session 2025-26 by the Govt. which has been communicated to all affiliated colleges / institutions vide this office letter No. 239/UUC dated 10.02.2014 which may please be referred to.
